John Raine: NHS Scotland Chairs meetings and Chairs meetings with the Cabinet Secretary on 2nd May and 10th June have covered a wide range of issues primarily concerned with performance against HEAT targets and including discussion around A&E performance; TTG performance and unavailability issues; cancer waiting times and sickness absence rates.

Boarding, representing "sub optimal care" has been discussed along with the role of Chairs in taking forward and reviewing performance in respect of hospital standardised mortality ratios.

The 2020 Workforce Vision, subsequently launched at the NHS Scotland conference, has been commended and needs to be spread across NHS organisations.

Chronic pain services have moved up the agenda all Boards said to have indicated their support to progress improvement work by implementing the Scottish Service Model. Scottish government is committed to accelerate progress to deliver the improvement programme. Work is underway to include improvement plans for chronic pain services into Board local service delivery plans for 2014 and for progress to be monitored through the annual review process. Cabinet Secretary has set out a commitment to establish residential specialist intensive pain management services in Scotland. Boards were asked to provide an update on plans to implement the Scottish service model, identify barriers and seek solutions to ensure progress.

A meeting of Board Chairs, and representatives of Scottish Government and Chief Executives, held on 13th May, committed to the concept of working jointly as a so-called "guiding coalition" to further the government 2020 vision for achieving high quality patient centred health services.

David Davidson: 16th May MK Opening; 22nd May Aberdeen University Session at Royal College of Physicians in Edinburgh on Governance for Chairs, Chief Executives and Audit Chairs. This was a discussion around research carried out across UK Public Sector Organisations on Governance, the role of Chairs and Chairs of Audit on Board Governance and the interface between Chairs and Chief Executives in Governance and appointment and dismissal of Chief Executives. The discussion also covered the role of Non Executive Directors, their purpose and support for them including Induction. A point missed in the research. It was very English based where in Health different systems are in place; 23rd May Chaired Resilience Committee; 27th May Private meetings with Internal and External Auditors; 30th Lecture by Erica Reid on care in the Community; 7th June Session conducted by Prof John Bolton at SBC on Integration and Rebalancing Care. Interesting examples of good and poor practice; 18th June Workshop at Borders College.

There are four groups (of which I am on one) reporting into programme board. The first interim report is due in December.
