Request

Response

We operate an acceptable internet use policy which allows staff to access the internet for social purposes during official breaks and outwith core hours.

Please find below a list based on the sites with the <u>largest amount of data</u> downloaded from them. It is not necessarily representative of those sites with the highest number of visits.

Our version of Internet Content filter does not have the capability to provide this information. Consequently we cannot answer the 2nd part of the request to list the number of hits for each site: this information is not available to us.

Only the top 85 sites have been provided as the remainder of the top 100 were unidentifiable IP addresses or included sub-domains that were amalgamated into the main domain shown above (e.g. images-amazon.com were included with amazon.com).

If following this review, you remain dissatisfied with the outcome, you may appeal to the Scottish Information Commissioner and request an investigation of your complaint. Your request to the Scottish Information Commissioner should be in writing (or other permanent form), stating your name and an address for correspondence. You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
