The focus of the Senior Leaders Forum was on strategic discussions on budgets and communications.

Chairs meeting with the Cabinet Secretary received a presentation on the current state of play on progress towards the start of IJBs from April 1<sup>st</sup>.

The Chairs national group last year commissioned a programme of learning opportunities to enhance the collective and individual abilities of executive and non executive board members to improve quality within their organisations. The work has been developed by HIS and NES and proposals include master class opportunities; bespoke Board development sessions and individual learning opportunities. The Board will no doubt wish to embrace this programme as it emerges.

A Board diagnostic tool with accompanying good practice guide has also been developed under the auspices of NES and the use of this tool in Borders Health Board will be discussed shortly.

A poster was submitted for the NHS Scotland event in June describing the Board's 360degree appraisal as a national pilot. This was one of 541 poster abstracts submitted and disappointingly did not make the final selection. Adjudicators comments included: "Really interesting approach from a leadership and infrastructure building perspective and lots to learn for other boards, well worth sharing" and also "Topical piece of work with robust methodology to achieve the desired outcome". My thanks go to Dr Marilyn Aitkenhead, Head of Psychological Therapies Training and Development, for putting together a quality poster.

**Stephen Mather:** I attended a meeting of Clinical Governance chairs at Delta House, Glasgow. There was a presentation on data interpretation followed by a Chatham House rules discussion on a number of matters. One matter of common concern was the conflict of interests for NEDs who also sit as voting members of IJBs.
