Freedom of Information request 3-17

Request

I would like to amend the request regarding psychiatric patients being sent out of their respective counties/trust/board areas and add in an additional point specifying an adult/CAMHS breakdown, please discount yesterday's request and proceed with this one, many thanks indeed for your help:

- 1. Over the last five years (2012, 2013, 2014, 2015, 2016), how many patients were sent out of the county/trust area for inpatient treatment? Please give the number of patients per year and specify whether they were 18 and over, or under 18 if the trust deals with CAMHS.
- 2. For each patient, please state where/how many miles away they were sent
- 3. What was the total cost per year of sending these patients away/out of area for care? (an average day rate is fine to save you from tallying it all up)
- 4. Over the last five years, how many times has it not been possible to find a psychiatric patient a bed at all? Please give the number of occasions per year.
- 5. Over the last five years, have there been any occasions where bed and breakfasts/hotels/other accommodation types have been used instead of hospital beds, because an inpatient bed wasn't available? If so when, and where was it/how many miles away was it?

Response

 NHS Borders aims to provide patient care within local services. Where necessary NHS Borders also commissions psychiatric services from NHS Lothian as the main provider of care and through various Service Level Agreements in place, the details of patients treated in NHS Lothian and associated costs are shown below in the response to Q3 as table 1.

On occasion patients may need to receive inpatient psychiatric services from other Scottish providers. NHS Borders does not hold the information requested. Therefore information provided and shown in response to Q3 in table 2 below is nationally recorded from Information Service Division Scotland (ISD).

In exceptional circumstances patients may need to receive psychiatric care from another provider out with the Service Level Agreement contracting arrangements. Manual trawl of invoices received for patients treated under Extra Contractual Referrals and out with NHS Scotland would be out with the parameters of FOI legislation. Therefore under Section 12 of the FOI(S)A we are not required to provide.

2. The distance to NHS Scotland services are varied depending on location of the units providing the required patient care. The table below gives an indicative mileage from Borders General Hospital to each Scottish provider used for psychiatric inpatient services:

Your request to the Scottish Information Commissioner should be in writing (or other permanent form), stating your name and an address for correspondence. You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
