Response

- 1. NHS Borders aims to provide patient care within local services and where necessary NHS Borders also commissions psychiatric services from NHS Lothian. In exceptional circumstances patients may need to receive psychiatric care from another provider NHS Borders does not have a singular database that holds this information and a manual trawl to identify patient numbers is out with NHS Scotland parameters of FOI legislation. Therefore under Section 12 of the FOI(S)A we are not required to provide this information..

If following this review, you remain dissatisfied with the outcome, you may appeal to the Scottish Information Commissioner and request an investigation of your complaint. Your request to the Scottish Information Commissioner should be in writing (or other permanent form), stating your name and an address for correspondence. You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
