## Freedom of Information request 92-17

## Request

- 1. Please provide details of the number of children and young people referred by a Local Authority for becoming Looked After in each of the last five years and the year to date (February 2017).
- 2. Please provide details of the number of mental health assessments which have been undertaken for Looked After children/young people in each of the last five years and the year to date (February 2017).
- 3. Please provide details of how many mental health assessments were undertaken for Looked After children/young people within four weeks between November 2015 and February 2017.
- Please provide details of what form the required 'mental health assessment' for Looked After children/young people takes, and who carries out the assessments.

## Response

Please note the following figures are for Looked After Children who are away from home:

4. The initial health assessment includes a mental health screening assessment. The mental health component of the assessment has been agreed in partnership with CAMHS service. Strength and Difficulties Questionnaire (SDQ) was introduced, in addition, at the end of 2015 for school aged children. The initial assessments are carried out by paediatrician (under 12s) and specialist LAC nurse (over 12 years).

If you are not satisfied with the way your request has been handled or the decision given, you may ask NHS Borders to review its actions and the decision. The request for a review should include your name and address for correspondence, the request for information to which the request relates and the issue which you wish to be reviewed. Please state the reference number **92-17** on this request. Your request should be made within 40 working days from receipt of this letter.

If following this review, you remain dissatisfied with the outcome, you may appeal to the Scottish Information Commissioner and request an investigation of your complaint. Your request to the Scottish Information Commissioner should be in writing (or other permanent form), stating your name and an address for correspondence. You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
