Request & Response

I have a request regarding treatment of Hepatitis C, does your trust treat Hepatitis C? Yes

How many patients with Hepatitis C are registered, or recorded as under you care? **We currently have 11** patients.

By way of explanation, I am hoping to understand the number of patients with the disease that are waiting for treatment, as well as in treatment. Any figure you could supply to answer this would be helpful.

NHS Borders does not hold data on how many patients are waiting on treatment. We treat patients as quickly as possible therefore we do not have a waiting list.

Please could you supply the following information, for patients with hepatitis C, for the last month if possible. Please use the tables to enter by genotype as possible thank you.

Please note these are patients on treatment currently, not just started in the last month. These patients are at various stages of treatment.

If your systems do not support the ability to split by treatment, please supply total treated by the genotype split. Similarly, if you are unable to split by genotype, please just split by treatment type.

As the number of events in some areas are very small and in accordance with the Code of Practice for Official Statistics any number that is less than five, actual numbers and potentially identifiable information is withheld to help maintain patient confidentiality due to potential risk of disclosure. If you are not satisfied with the way your request has been handled or the decision given, you may ask NHS Borders to review its actions and the decision. The request for a review should include your name and address for correspondence, the request for information to which the request relates and the issue which you wish to be reviewed. Please state the reference number **183-17** on this request. Your request should be made within 40 working days from receipt of this letter.

If following this review, you remain dissatisfied with the outcome, you may appeal to the Scottish Information Commissioner and request an investigation of your complaint. Your request to the Scottish Information Commissioner should be in writing (or other permanent form), stating your name and an address for correspondence. You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
