Referrals to Mental Health Teams do not contain diagnosis information that can be pulled from the system to look at reasons for referral. This would involve looking through patient notes for each of the referrals and diagnosis to determine how many relate to eating disorders. The cost of carrying out this work would exceed the limit set in the Fees Regulations of the FOI(S)A 2002 and we are therefore not required to provide.



12. NHS Borders do not have any plans to implement the FREED model.
