Following my previous email, may I also ask, under the freedom of information act, what percentage of those admitted to borders general hospital in the last year are related to alcohol? What is the percentage of that for the year previously?

You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
