Response

NHS Borders does not record the nationality of staff as this is not a mandatory requirement. Accordingly, in terms of Section 17 of the Freedom of Information (Scotland) Act 2002 I must advise the information sought is not held.

 - (b) General Surgery Three non-British EU nationals working / employed during these dates
 - (c) Intensive Care Unit One non-British EU national working / employed during these dates
 - (d) Critical Care Not Applicable, combined service with (c) above
 - (e) Paediatric ward No non-British EU nationals working / employed during these dates
 - (f) Geriatric ward No non-British EU nationals working / employed during these dates
 - (g) Maternity unit No non-British EU nationals working / employed during these dates
 - (h) Oncology unit No non-British EU nationals working / employed during these dates

If you are not satisfied with the way your request has been handled or the decision given, you may ask NHS Borders to review its actions and the decision. The request for a review should include your name and address for correspondence, the request for information to which the request relates and the issue which you wish to be reviewed. Please state the reference number **399-17** on this request. Your request should be made within 40 working days from receipt of this letter.

If following this review, you remain dissatisfied with the outcome, you may appeal to the Scottish Information Commissioner and request an investigation of your complaint. Your request to the Scottish Information Commissioner should be in writing (or other permanent form), stating your name and an address for correspondence. You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
