Request

I wish to obtain the following:

- 1. Which facilities within the health board area have provided in-patient mental health services, including residential and secure units, between 2011 and 2017, both dates inclusive?
- 2. Between 2011 and 2017, both dates inclusive, how many seizures of psychoactive substances have taken place at facilities specified in question 1? Please specify how many seizures took place at each facility.
- 3. Between 2011 and 2017, both dates inclusive, how many assaults on staff have taken place at facilities specified in question 1? Please specify how many assaults took place at each facility.
- 4. Between 2011 and 2017, both dates inclusive, how many assaults on staff have taken place, in which psychoactive substances have been deemed to be a factor in the incident? Please specify how many incidents have taken place at each facility.

Response

- 1. The facilities within NHS Borders which provide in-patient mental health services are Huntlyburn, East Brig, Lindean, Cauldshiels and Melburn Lodge.
- This information is not held electronically but may be held in a patient's notes but this would require a manual trawl of all records. The cost of carrying out this work would exceed the limit set in the Fees Regulations of the FOI(S)A 2002 and therefore under Section 12 of the FOI(S)A 2002 we cannot provide.
- 3. Assaults on staff within Mental Health in-patients units: there are no secure units.

If following this review, you remain dissatisfied with the outcome, you may appeal to the Scottish Information Commissioner and request an investigation of your complaint. Your request to the Scottish Information Commissioner should be in writing (or other permanent form), stating your name and an address for correspondence. You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
