## Request

2. The metrics used to assess the success of the venture and the performance against those metrics.

3. Any identifiable costs associated with backfill costs for clinicians and others who attended

## Response

The event was the British Medical Journal Careers Fair held at the Business Design Centre (BDC) in London on 21 and 22 October 2016.

- 1. The overall costs of attendance at this event amounted to £4,260, including travel/accommodation, registration, purchase and hire of items specifically for the event.
- 2. No metrics were set for the success of the event by the Medical Director. The purpose of our attendance was to raise the profile of NHS Borders throughout the United Kingdom and beyond, highlighting the opportunities and medical careers available within our region and also to highlight the benefits that Scottish Borders can offer as a fantastic place to live and work. A mailing list of interested doctors was established from attendees at the event.
- 3. There were no identifiable costs associated with backfill for the three clinicians who attended.

You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
