Recent weeks have been marked by intense activity in our hospitals and across primary and community services. Front line staff at BGH, many of whom are long servicing employees, have described the pressures as unprecedented in their experience.

We have seen a marked deterioration in some of our waiting time statistics as a result yet the quality of services across NHS Borders is being maintained and there have been many examples to illustrate the commitment of staff to deliver the best possible care in difficult circumstances. I know the Board will wish to formally express its support and thanks to all staff for rising to the ongoing challenges.

**Malcolm Dickson:** During a discussion at a recent Clinical Governance Committee, it was agreed that Cliff Sharp and David Love would meet with Malcolm Dickson so that the latter could gain a better understanding of current practice in reporting deaths to the Procurator Fiscal. This meeting took place on 9<sup>th</sup> January, following an exchange of relevant guidance, a useful and searching discussion ensued mostly focussing on the

admittedly very low risk of criminal actions by health personnel, alleged/suspected negligence/error, and how families of deceased were made aware of avenues available should they have any dissatisfaction/concerns in relation to a death. The discussion developed to include the changing culture within the NHS, and NHS Borders in particular, and Malcolm left the meeting with a much greater degree of assurance on all these matters than he had before the meeting.
