## Request

Timescale: to allow consistency, the time period selected was the most recent 4 month period available for both sectors: July to October 2018.

Dupixient (dupilumab), Diflorasone diacetate 0.05\% (Psorcon) and Halbetasol proprionate 0.05\% (Ultravate) are not listed in the Primary Care system so were unable to be included in the search. Desoximetasone 0.25\% (Topicort) and Halcinonide 0.05\% (Halog) have not been used.

Unless otherwise stated (by inclusion of a brand name), the Approved Name has been used. Several of these drugs have multiple uses which cannot be determined from Prescribing Data alone.

If you are not satisfied with the way your request has been handled or the decision given, you may ask NHS Borders to review its actions and the decision. If following this review, you remain dissatisfied with the outcome, you may appeal to the Scottish Information Commissioner and request an investigation of your complaint. Your request to the Scottish Information Commissioner should be in writing (or other permanent form), stating your name and an address for correspondence. You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
