Freedom of Information request 53-18

Request

Under the Freedom of Information (Scotland) Act 2002 I would like to request the following:

- The number of patients aged under 16 who have been prescribed some form of contraception in the last three years.
- Could you please break this down by year, and by age of the patient.
- Could you also please state which type of contraceptive method was prescribed, for example the pill, implant, injections or IUD.

It was today reported in a Scottish newspaper that girls aged from 13 were being given the contraceptive implant in one health board area, and if possible I would like to compare this to other boards in Scotland.

From the reporting, I understand that it may be difficult to include the exact figures of some ages being given - for example the pill or another form of contraceptive- therefore, I would be happy to receive information which does not say how many people - say aged 13- where given the implant, but just notification that this has happened.

However, this would only be if the health board could not provide the exact number of those in this age group for the certain type of contraceptive. Ideally, I would like a full breakdown.

If following this review, you remain dissatisfied with the outcome, you may appeal to the Scottish Information Commissioner and request an investigation of your complaint. Your request to the Scottish Information Commissioner should be in writing (or other permanent form), stating your name and an address for correspondence. You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
