Request

- 1. In your trust, in the past 3 months [latest 3 months available], how many asthma patients aged 18 and over have been treated?
- 2. How many paediatric asthma treated patients [aged 6-17] have been treated?
- 3. How many severe asthmatic patients [BTS guidelines, step 4 or 5] have been treated?
- 4. How many severe allergic asthma patients [severe persistent confirmed allergic IgE-mediated asthma OR severe persistent confirmed allergic eosinophilic asthma] have been treated with:
 - a. Omalizumab [Xolair]
 - b. Mepolizumab [Nucala]
 - c. Reslizumab [Cingaero]
 - d. Benralizumab [Fasenra]
 - e. Other [Please state]
- 5. How many paediatric severe asthma patients treated with Xolair/omalizumab?
- 6. How many asthma clinics are run per month?
- 7. What is the average number of severe asthma patients per clinic?
- 8. Do you treat non asthma patients with Omalizumab [Xolair]? If yes, how many of for what condition?

Response

- In the past 3 months (Nov 17 to Jan 18) 75 patients were seen at the Respiratory Specialist Nurse clinics. We are unable to provide data on numbers of patients seen at Consultant Outpatient Clinics as this is not held electronically and would require a manual trawl of all patient records and the cost of this would exceed the limit set in the Fees Regulations of the FOI(S)A 2002, therefore under Section 17 we are not required to provide.
- NHS Borders are unable to provide data on numbers of paediatric patients treated for asthma as this is not held electronically and would require a manual trawl of all patient records and the cost of this would exceed the limit set in the Fees Regulations of the FOI(S)A 2002, therefore under Section 17 we are not required to provide.
- 3. In the past 3 months (Nov 17 to Jan 18) 5 patients with severe asthma were seen at the Respiratory Specialist Nurse clinics. We are unable to provide data on numbers of all severe asthmatic patients treated as this is not held electronically and would require a manual trawl of all patient records and the cost of this would exceed the limit set in the Fees Regulations of the FOI(S)A 2002, therefore under Section 17 we are not required to provide.
- 4. NHS Borders have <5 patients with severe allergic asthma who are treated with Xolair, we do not currently use any of the other treatments listed.

- 5. NHS Borders have <5 paediatric patients with severe asthma who are treated with Xolair.
- 6. NHS Borders do not run disease specific clinics, 4 multi-respiratory disease clinics are held weekly.
- 7. There is an average of <1 severe asthmatic patient per clinic.
- 8. No.

If following this review, you remain dissatisfied with the outcome, you may appeal to the Scottish Information Commissioner and request an investigation of your complaint. Your request to the Scottish Information Commissioner should be in writing (or other permanent form), stating your name and an address for correspondence. You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
