Request

 If you cannot reveal the name of the individual this is understandable, however, it would be preferable.
- The amount paid in pension contributions to public relations, media and press staff in the last three years.
 Again, could you break this down by year and individual.

Response

NHS Borders employs <5 staff members with responsibility for public relations, media and press office.

The following are the pay and pension costs incurred by NHS Borders on public relations, media and press officers.

Gross Pay Costs are before deductions for the employee's income tax, national insurance and pension contributions.

Pension costs are those incurred by NHS Borders payable to the Scottish Public Pensions Agency for the NHS Superannuation Scheme and the alternative workplace pension scheme available to NHS Borders employees - the NEST Corporation Pension Scheme.

If following this review, you remain dissatisfied with the outcome, you may appeal to the Scottish Information Commissioner and request an investigation of your complaint. Your request to the Scottish Information Commissioner should be in writing (or other permanent form), stating your name and an address for correspondence. You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
