## Freedom of Information request 226-18

## Request

In relation to your recent request for clarification of FOI 152-18 please find below the questions raised and processed as a new request:

- Does ARFID meet the criteria for tier 3 services?
- While ARFID is a DSM 5 diagnosis rather than a specific ICD-10 diagnosis, my understanding is that it is now coded within ICD-10 as F50.82. Previously it would have been included within the F50.8 rather than F50.9 category according to ICD-10.
  - I. Could you clarify whether or not you keep ICD-10 diagnoses electronically and
  - II. If so how many patients over the last 5 years have received a diagnosis and treatment under these ICD-10 codes F50.8, F50.9 and F50.82.

## Response

- Yes.
- (i) Within NHS Borders ICD-10 diagnoses are recorded electronically but only to a 4 digit level i.e. F508 or F509. There is no 5<sup>th</sup> digit in mental health coding, this is inline with all Scotland Health Boards.

(ii) Please find below the number of patients who have received a diagnosis of these codes over the last 5 years:
