## Request

Please provide me with

- a. The Boards expenditure for mental health for the financial year 2017/18 and the budget for 2018/19.
- b. The specific expenditure and budget for CAMHS for the same periods.
- c. The specific expenditure and budget for Drug and alcohol misuse [CADS] for the same periods.
- d. The specific expenditure and budget for Health services provided to the prisons in the Board Area".

## Response

- a. The expenditure within Mental Health for 2017-18 was £12.7m
  The recurring budget for Mental Health for 2018-19 is £12.3m. This excludes non-recurring funding which may become available during the financial year.
- b. The Mental Health expenditure and budget given in this question exclude the expenditure and budget detailed for CAMHS & Drugs and Alcohol Misuse in b) & c) below.
  - The expenditure within Mental Health CAMHS for 2017-18 was £0.9m The recurring budget for Mental Health CAMHS for 2018-19 is £0.9m
- c. The expenditure within Mental Health Drugs & Alcohol Misuse for 2017-18 was £0.4m The recurring budget for Mental Health Drugs & Alcohol Misuse for 2018-19 is £0.3m. This excludes non-recurring funding which may become available during the financial year.
- d. There are no prisons within the Scottish Borders and NHS Borders does not have responsibility for health in any prison.

Your request to the Scottish Information Commissioner should be in writing (or other permanent form), stating your name and an address for correspondence. You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
