Freedom of Information request 288-18

Request

I am writing to obtain information about how often the mental health beds in your health board area are fully occupied. Specifically I would like to know:

- 1. How many inpatient mental health beds does your health board have? How many of these are acute mental beds?
- 2. On how many dates during 2015/16, 2016/7 and 2017/8 have: a)all of the acute beds been at 100 percent occupancy? b)all of your in-patient mental health beds been full?
- 3. How many patients in 2015/16, 2016/7 and in 2017/8 have been provided with a bed space from a different health board due to capacity issues in their own health board area? Please also provide total admission figures.
- 4. How many patients in 2015/16, 2016/7 and in 2017/8 have you had to turn away because there were no beds available?

Response

- 1. NHS Borders has 63 inpatient mental health beds, of these 19 are classed as acute mental beds.
- NHS Borders are unable to provide this data on a daily basis as the cost of extracting this data would exceed the limit set in the Fees Regulations of the FOI(S)A 2002 and therefore we are not required to provide. Under Section 15 Duty to provide advice and assistance we can provide the following data which shows average monthly occupancy rates:

If following this review, you remain dissatisfied with the outcome, you may appeal to the Scottish Information Commissioner and request an investigation of your complaint. Your request to the Scottish Information Commissioner should be in writing (or other permanent form), stating your name and an address for correspondence. You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
