Out of Hours Cover

- 1. Borders Emergency Care Service [BECS] provides urgent out-of-hours primary care for the Scottish Borders including the Eildon Medical practice.
- 2. BECS employs a total of 33 salaried and sessional GPs.
- 3. Eight sessional GPs and one salaried GP commute from areas outwith the Scottish Borders.
- 4. BECS does not have access to patient GP records. The service can access primary care special notes via eKIS and the Emergency Care Summary. BECS also has access to patient hospital records. BECS uses the Adastra patient administration software and call sheets for patients seen during out-of-hours are sent to the relevant practices at 0800 hours when the service closes.
- 5. All BECS GPs are fully trained and qualified GPs.

If you are not satisfied with the way your request has been handled or the decision given, you may ask NHS Borders to review its actions and the decision. If following this review, you remain dissatisfied with the outcome, you may appeal to the Scottish Information Commissioner and request an investigation of your complaint. Your request to the Scottish Information Commissioner should be in writing (or other permanent form), stating your name and an address for correspondence. You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
