# NHS BORDERS – ANNUAL REVIEW 2009

# AT A GLANCE HEAT TARGET PERFORMANCE - 2008/09

The number of **3-5 year olds registered with an NHS Dentist has increased** from 64.28% in April 2008 to 66.3% in December 2008. The two new Dental Centres will help to increase the numbers of children registered.

At the end of March 2009, **31.4% of babies were being exclusively breastfed at 6-8 weeks old**, slightly below the trajectoryAn Infant Feeding Advisor will be appointed to improve breastfeeding rates.

The target of 95% of laboratory requests to include a community health index has been mainly met throughout 2008/09 with the lowest rate in the period being 94%.

**100% of staff** now have an **agreed personal development plan** mapped to the **Knowledge & Skills Framework** in place.

**NHS Borders delivered on its cash efficiency and savings targets** in 2008/09 and future savings plans are being developed.

The target to **reduce the numbers of people attending Accident & Emergency in 2008/09 has been achieved** and an action plan is in place to meet the lower targets set for 2009/10 which also include attendances at the Minor Injury Units.

In 2008/09 the national target set was that no patient should wait longer than **15 weeks** for an outpatient appointment following GP referral from the 31<sup>st</sup> March 09. The same target was set for inpatient and day case treatment. In Borders, from March 09 no patients waited longer than **12 weeks** from GP referral or for inpatient or day case treatment.

**Progress has been made to reduce emergency in patient beds for people over 65.** A number of initiatives are underway including anticipatory care planning and a Length of Stay group has been set up to look at reducing length of stay across specialties. The discharge process is also being redesigned.

Figures for the third quarter of 2008/09 saw a **rise in anti-depressant prescribing** (when a reduction was being planned). This was seen across Scotland. Initiatives to improve access to psychological therapies have been developed to reduce future prescribing rates.

The Patient Safety Programme is on track with improvements to the quality of healthcare experience including for hand hygiene and hospital acquired infection rates.

At the end of March 2009, there were **no delayed discharges over 6 weeks**. NHS Borders works in partnership with Scottish Borders Council to manage discharges for people with complex care needs.

#### Higher Smoking Cessation Rates

During 2008/09 548 people had successfully quit one month after receiving support from Borders Smoking Cessation Services
