#### 1. INTRODUCTION

The Freedom of Information (Scotland) Act 2002 (FOISA) was introduced on 1<sup>st</sup> January 2005. The Act requires all public authorities in Scotland to make any information they hold available on request. The implementation of the Act required the development of an entirely new system to manage requests for information, as well as changes in our individual and organisational attitudes to the confidentiality of the information we produce and of our internal and external communications.

As FOISA introduced new concepts, the first year tested out the procedures which had been put in place following implementation. Systems were audited and developed and the protocol was reviewed and updated in November 2006.

This second year has seen a rise in requests During 2005/06 a total of 104 requests were received with 138 being received. During 2006/07 an increase of 32.6%.

This Annual Report aims to set out the impact of the FOISA on the organisation and demonstrate how we have performed against key performance indicators. The report covers the period 1<sup>st</sup> April 2006 to 31<sup>st</sup> March 2007 the second full year following implementation of FOISA. We have been able to start to produce more meaningful data by providing a comparison with activity in the previous year (1<sup>st</sup> April 2005 – 31<sup>st</sup> March 2006).

The range of requests has remained much the same, with the majority coming from the media. Many requests for from this source are for data compiled by the Information Services department, requests which are sent to all the Health Boards to build a picture of a particular situation across Scotland. Alcohol and drug abuse statistics, the cost of compensation claims and directors' and consultants' salaries have been common themes as well as catering costs and information about drug prescribing. A full list of the requests received during 2006/07 is provided in Appendix 1.

#### 2. IMPLEMENTATION

#### 2.1 Publication Scheme

The FOISA requires each public authority to draw up a publication scheme. The publication scheme sets out the documents which the organisation will routinely make available to the public, the organisation's contacts and the fee charging scheme. The Scottish Executive Health Department established a national working group to develop a model publication scheme for all NHS organisations within NHS Scotland to sign up to. This publication scheme was approved by the Scottish Information Commissioner on 16 June 2004 and is posted on the NHS Borders website (www.nhsborders.org.uk).

#### 2.2 Request Handling

A database has been established to record requests and produce appropriate activity reports. The database records the date of receipt and response, who is handling the request, the date the response is made and any exemptions or other issues. We currently supplement this system with a manual tracking system which allows any member of the team to establish at what stage the request is, as well as providing a visual reminder of the due date of each response.

#### 2.3 Reporting Arrangements

During the early implementation period, quarterly reports were presented to Borders NHS Board. Once the system was established, regular activity reports and an Annual Report for 2005/06 were presented to the Caldicott/Information Governance Group. The Caldicott Group/Information Governance Group has a remit of monitoring information governance issues and developing a framework for ensuring the organisation meets the national information governance standards.

# 3. ACTIVITY

# 3.1 Categories of Requests

During 2006/07, the highest number of requests, 74 (53.6%), were from the media - increase of 34% on last year's activity. The highest increase in the number of requests was from members of the Scottish Parliament which rose from only 8 requests in 2005/06 to 27 in 2006/07. Only17.3% requests were made by members of the public.

#### 3.2 Response Times

The FOISA requires public authorities to respond to requests by the 20<sup>th</sup> working day following receipt of the request.

The table below sets out our compliance with the statutory deadlines.

Of the 138 requests received 3 requests (2.1%) breached the 20 working day deadline. These requests and the reason for missing the deadline are set out overleaf.


When it appears likely that a deadline will be breached, it is our policy to contact the applicant and explain the reasons for the possible delay. In each case the applicant has responded positively to this approach and accepted the reason for an extension. Under the FOISA, the applicant's agreement to a delayed response does not alter the outcome. It still constitutes a breach of compliance and we record them as such. However, none of these cases has resulted in a request for an internal review or a complaint to the Information Commissioner.

The response time varies greatly depending on the type of request. Some can be answered within a day, for example, when the request is for a copy of a particular document. Other requests are very complex. They may require information to be collected from a number of sources, such as requests for 'all minutes, reports, e-mails and correspondence' relating to a particular topic. Other requests are for data which we hold, but which we do not routinely


report on. Wherever possible, we provide the information in these cases, but it often takes time to collate the information.


The graphs below show the response times for April 2006 – March 2007 and April 2005 – March 2006.

## 3.3 Outcome of Requests

It is not always possible to provide the applicant with all the information they have requested. This may be because we do not actually hold all of the information, or because some of it falls into one of the exemption categories (see 3.4).

In some cases, retrieving and collating the information would prove too costly. In these cases, the direct and indirect costs of locating, retrieving, collating and providing the information are calculated against the formula set out in the Fees Regulations, and if they exceed £600.00, we are entitled to decline to provide the information to the applicant. This is often the case where records are kept in manual files, and to retrieve and collate the information would take a considerable number of staff hours.

Of the 138 requests 65 (47.1%) were provided with all the information requested. Overall, 78% of applicants received all or part of the information they requested.

## 3.4 Use of Exemptions

Under FOISA a public authority can refuse to provide requested information that it holds if the information falls within one or more of the categories of exempt information listed in Part 2 of the Act. Exemptions may be applied to all of the information requested or to only part of a request. One or more of the exemptions was applied to some, or all of the information considered in 5 (3.7%) of the 138 requests received. The most commonly applied exemption relates to Section 38 – Personal Information. Often this means that the information requested is protected under the Data Protection Act 1998. Appendix 2 provides more detail on the use of exemptions.

#### 3.5 Resource Implications

In order to address resource issues and to monitor the time spent dealing with FOI requests individual departments have been asked to log the amount of time spent dealing with FOI requests. The majority of people involved in providing responses consider this to be part of their general workload and do not record the time it takes to complete the task. As yet detailed information has not yet been returned to the FOI office. However, in responding to FOI requests, the following levels of staff made a significant contribution to the response: -

The Information department provide a significant number of responses. This is usually in the form of activity data. The Information department treats these requests as part of their workload of ad hoc requests at present. The Finance department also handle a number of requests. These requests are generally for information on salaries of key staff groups or the cost to the organisation of specific initiatives.

Many of the requests require input from more than one department.

#### 2. INTERNAL REVIEW

Under FOISA, when the organisation withholds requested information or does not comply with any aspect of FOISA, the applicant is entitled to request that the organisation review its decision or the way in which the request was handled.

A panel that includes a Non-executive Director and a Director carries out the internal reviews. The panel has the option to uphold or overturn the original decision, or partially uphold the original decision and release some of the requested information.

No Internal Reviews were requested during the period 1<sup>st</sup> April 2006 – 31<sup>st</sup> March 2007.

#### 3. REVIEW BY THE OFFICE OF THE SCOTTISH INFORMATION COMMISSIONER

The Office of the Scottish Information Commissioner (OSIC) is responsible for enforcing the Freedom of Information (Scotland) Act 2002. The Commissioner has legal powers to ensure the public's right to freedom of information is upheld.

If an applicant is dissatisfied with the outcome of an internal review, he or she may apply to OSIC to request an investigation.

No OSIC reviews were requested during the period 1<sup>st</sup> April 2006 – 31<sup>st</sup> March 2007.

#### 4. MONITORING

The Business Management Department maintains a register of all requests for information other than those requesting information which has already been published on the NHS Borders website. The register includes the action taken on each application, any fees charged, the time taken to fulfil the request. This register also helps to ensure consistency in dealing with requests, by providing information on whether similar requests have been made and what information was provided, exemptions claimed and any reviews carried out.

#### 5. CHALLENGES

Since the introduction of the FOISA several issues in the management of FOI requests have been highlighted:

#### 5.1 Resource Implications

At the present time there is no detailed information available on the amount of time staff spend responding to FOI requests (see 3.5 above). A request for this information is included in the standard e-mail request sent to staff. However, to date the information has only been provided on three occasions. Following up to collect this information is time consuming and does not add value to the process.

Now that FOISA has become part of our services, the majority of staff consider this work to be part of their normal duties.

The Business Management Department has recruited an additional member of staff who assists with FOISA request handling. This has helped to spread the workload, particularly at times when a large number of requests are received over a short time period.

#### 5.2 Deadlines

Difficulties in meeting the 20 working day deadline have been experienced when the request requires the collation of large quantities of correspondence which also has to be checked and redacted prior to release.

There have also been instances where third party information may be identified quite late on in the collection process and there can be difficulties contacting the individuals concerned.

Responses can be delayed where it has taken a considerable amount of time to collect and collate the information and it then has to be checked by a senior manager or a member of the Board Executive Team.

#### 5.3 Staff Awareness

Awareness raising and training sessions were undertaken with a range of staff groups prior to implementation of FOISA and all staff were provided with a leaflet. An information sheet about FOISA and how it impacts on the staff of NHS Borders is provided in the induction pack which all new staff receive. There is also an FOI intranet page which has been available to staff since September 2006.

A number of staff have considerable experience of responding to FOISA requests, however, we recognise that some departments need some additional training. Further awareness raising sessions are planned during 2007 for managers and staff.

#### 5.4 Application of Exemptions

Interpretation of the correct exemption to apply and national guidance is being developed by the OSIC on an ongoing basis.

In addition, the Data Protection Act is frequently a factor in withholding information as, in a small Board such as NHS Borders, requests for information on posts, grades, salaries and place of work could easily allow individual members of staff to be identified and there would be an expectation among most staff that this information would be confidential. The Business Management department consults with the Data Protection Lead on these issues.

#### 5.5 Availability of Information

One of the main reasons for information not being provided to an applicant is the fact that within NHS Borders the information is not available in a format that is easy to collate, e.g. information held in personnel files which would necessitate a manual trawl of the hard copy records. This applies to many of the requests for information from the Human Resources Department. In these cases, collection of the information is deemed too costly to collect and the exemption for Excessive Cost of Compliance is frequently used.
