Request

Under FOI legislation could I please request the following:

1. How many people were referred to adult mental health services within the past 5 years?

Of all the people referred to adult mental health services:

- a) How many were seen
- b) How many of those seen were subsequently referred on to psychological therapies
- c) How many were declined
- d) How many did not manage to successfully opt-in successfully for their outpatient appt.

Response

Please find below the number of referrals recorded on NHS Borders' mental health database received for Adult Mental Health Services in the past 5 years. We are unable to identify from this data exactly a) how many patients were actually seen or c) how many were declined as this is not held electronically. This level of detail would only be available within a patient's notes and to extract this data would require a manual trawl of all notes and the cost of carrying out this work would exceed the limit set in the Fees Regulations of the FOI(S)A 2002, therefore we are not required to provide. Under Section 15 of the FOI(S)A 2002 Duty to provide advice and assistance shown below is a list of the referral outcomes which we do hold:

Your request to the Scottish Information Commissioner should be in writing (or other permanent form), stating your name and an address for correspondence. You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
