Request

I would like you to send me the locum agency spend in the AHP/HSS division of the hospital for Echocardiographers and Cardiac Physiologists who would most likely be in the Cardiology department, also Sonographers who would be in the Ultrasound/Imaging Department. I would like to know the spend from January 2018 - present, also including the amount of locums that this refers to per month, broken down on a monthly basis. In the breakdown if you could please include the agencies that provide the locums also broken down numerically.

Ideally this would read as below -

January 2018 - £34k Cardiology - £6k Sonographers Globe - Echocardiographer x 3 HCL - Echocardiographer x 2 Globe - Cardiac Physiologist x 5 Maxxima - Cardiac Physiologist x 2 RIG - Sonographers x 2

February 2018 - £37k Cardiology - £4k Sonographers Globe - Echocardiographer x 4

You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
