- 2) Can you please include a breakdown of the type of surgical fires incidents for the period 2010-2018, broken down by each year and characterised as follows:
 - a. chemical ignition
 - b. chemical related
 - c. diathermy related
 - d. equipment related
 - e. other reported in NHS Borders? Please provide a breakdown for each year.
- 3) What is the number of surgical fires incidents related to alcoholic skin preparation agents specifically reported in NHS Borders's for the period 2010-2018? Please provide a breakdown for each year.
- 4) Can you please include additional details on the number of surgical fires incidents that resulted in an injury for the patient, i.e. burn reported in NHS Borders for the period 2010-2018? Please provide a breakdown for each year.
- 5) Can you please describe what prevention protocols are in place to avoid surgical fires accidents in NHS Borders? Please attach a copy of any protocols.
- 6) Does NHS Borders provide any prevention training courses for operating theatre healthcare professionals on surgical fires incidents? If so please provide details.

This is also in accordance with the Code of Practice for Official Statistics any number that is less than five, actual numbers and potentially identifiable information is withheld to help maintain patient confidentiality due to potential risk of disclosure. - 6. No specific training is provided to this identified group however detailed below is what mandatory fire training is delivered to all NHS Borders staff:
 - E-Learning Fire Safety module completed on an annual basis
 - General Fire Safety Training on an annual basis
 - Participation in an Annual Fire Drill and (within a clinical environment this is not practically possible, but it can be achieved by either a physical walkthrough of working environment or a table top exercise).

If following this review, you remain dissatisfied with the outcome, you may appeal to the Scottish Information Commissioner and request an investigation of your complaint. Your request to the Scottish Information Commissioner should be in writing (or other permanent form), stating your name and an address for correspondence. You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
