Freedom of Information request 564-18

Request

In accordance with FOI, please provide figures for the amount paid to employees who are suspended in each financial year – 2015/16, 2016/17, 2017/18, and 2018/19 (to date).

Please also provide a breakdown of how many people were suspended, in each of those years, and reasons for the suspension.

If possible, please include the highest amount paid to a single individual, how long that person had been suspended for, and the reason for their suspension. (Please note, if you have concerns about identifying individuals, the most important part of this question is the total amount paid to that recipient).

Response

1. The number of staff suspended and the total amount paid to staff who were suspended is as follows:

Financial Year	No. of Employees Suspended	Total Payments Made During Suspension Period
2015/16	11	£75,606.62
2016/17	7	£67,880.30
2017/18	<5	£62,932.08
2018/19 to 31 August 2018	5	£20,320.66

An individual may be suspended for a period spanning more than one financial year. The table above counts the total number of staff suspended within each financial year, therefore some employees may be counted more than once.

2. Reasons for suspension are given in the table below:

If following this review, you remain dissatisfied with the outcome, you may appeal to the Scottish Information Commissioner and request an investigation of your complaint. Your request to the Scottish Information Commissioner should be in writing (or other permanent form), stating your name and an address for correspondence. You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
