Request & Response

1.1 Please state the total number of new multiple myeloma patients diagnosed in your health board area for the years 2015, 2016 and 2017 combined. Include patients that are primarily treated in your area originating from an island health board area

Within NHS Borders there were 24 new cases diagnosed.

1.2 Please state whether adult patients requiring intensive chemotherapy for acute myeloid leukaemia are treated within your health board, if they sent to a centre in another health board area or if there is some form of split arrangement.

Patients with acute leukaemia fit enough for intensive treatment are sent to Western General Haematology. Those for palliative/supportive care or gentle chemo (cytosine/azacytidine /hydroxycarbamide are managed at Borders General Hospital.

1.3 Please state the number of new patients attending Haematology department clinics during the calendar years of 2015, 2016 and 2017.

There were 707 new patients.

1.4 Please state the number of return patients attending Haematology department clinics during the calendar years of 2015, 2016 and 2017.

There were 6052 returning patients.

If following this review, you remain dissatisfied with the outcome, you may appeal to the Scottish Information Commissioner and request an investigation of your complaint. Your request to the Scottish Information Commissioner should be in writing (or other permanent form), stating your name and an address for correspondence. You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
