Situation

The Chairman, Mr John Raine, concludes his term of office on 31 March 2019. A successor has not been formally appointed following the last round of recruitment for Chairs of Health Boards. The Public Appointments Unit will shortly be re-advertising the role.

In the meantime the current Vice Chair, Mrs Karen Hamilton has been appointed by Scottish Ministers as Interim Chair of NHS Borders with effect from 1 April 2019.

There is therefore a vacancy in the number of Non Executive members of the Board and this has impacted on the membership of Board Committees.

Background

The Code of Corporate Governance details the Board's business processes and also sets out how the membership of its committees are agreed and advises that the Chair propose to the Board for approval the membership of Committees. By virtue of his/her appointment the Chair of the Board is an ex officio member of all Committees except the Audit Committee.

Any Committee, shall include at least one Non-Executive member, and may include persons, who are co-opted, and may consist wholly or partly of Directors. There are 14 ministerial appointed Directors of the Board. These are the Chairman, eight other Non Executive members and five Executive Directors.

In proposing the membership of Committees, the Chair shall have due regard to its purpose, role and remit, and accountability requirements. Certain Directors may not be appointed to serve on a particular Committee as a consequence of their positions. Specific exclusions are:

- Audit Committee Chair of the Board or any Executive Director.
- Remuneration Committee any Executive Director.

The Board shall appoint Chairs and Vice-Chairs of Committees to hold office for two years.

The persons appointed as Chairs of Committees shall usually be Non-Executive members and only in exceptional circumstances shall the Board appoint a Chair of a Committee who is not a Non-Executive member.

Vacancies occurring on any Committee shall be filled as soon as possible.

The Code of Corporate Governance also details that the Chair will nominate a Vice Chair for approval of the Board and subsequently the approval of the Cabinet Secretary.
