## Request

- Please supply a list of all brands of infant formula milk purchased by the NHS board for use in maternity units and the form in which it is provided (e.g. powdered, ready made bottles, etc.)
- For each brand of infant formula milk purchased, what was the total annual cost paid and volume received in the last available financial year and was the infant formula milk was purchased at full price, a reduced rate (if so, please give details of the reduction) or received free of charge.
- For each brand of infant formula milk purchased, please identify the supplier to the NHS Board

## Response

The following brands and the form in which it is provided is as follows:

- Aptamil, Cow and Gate and SMA 70 ml ready made bottles
- Cow and Gate standard teat and SMA nutrition hygienic teat

The total amount paid from 1 April 2018 to 4 March 2019 was £3,533.45, this was for 11,520 units. These units are charged as follows:

If following this review, you remain dissatisfied with the outcome, you may appeal to the Scottish Information Commissioner and request an investigation of your complaint. Your request to the Scottish Information Commissioner should be in writing (or other permanent form), stating your name and an address for correspondence. You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
