**Karen Hamilton:** Since the last meeting of the Board I have undertaken several visits and meetings in addition to those listed above including:-

- Attended the National Remuneration Committee event on 9 April 2019 where the aim of the event was to: enhance a shared understanding of the role and remit of Remuneration Committees; provide an opportunity for problem sharing; ensure Remuneration Committee chairs were confident in the effective use of national arrangements for executive and senior management appraisal and had the opportunity to discuss the new Turas Appraisal system; ensure participants understood the context for Remuneration Committees' work in relation to national leadership and talent management arrangements; and input to shape national support materials for Remuneration Committee work.
- Undertook a walkround of Huntlyburn and the Borders General Hospital with our new Chief Executive, Ralph Roberts on 25 April 2019 and a walkround of the Knoll in Duns on 27 May 2019.
- Met with Scottish Borders Council and NHS leads in relation to the Integration Agenda on 1 May 2019.
- Attended the Inaugural session of the Changing Places Project Group on 3 May 2019.

- Attended the Nursing and Midwifery Conference on 10 May 2019 entitled Person Centred Care.
- Along with the Chief Executive, met with South of Scotland political parties on 10
  May for an open round table discussion and it is anticipated that a further session
  will be undertaken later in the year.
- Attended the Chaplaincy Volunteers meeting and Sunday Service on 19 May 2019 which consisted of a short half-hour inter-denominational service in the Tryst, led by Worship Leaders from different backgrounds; retired ministers, lay personnel, trainees, etc. On a typical Sunday, between 5-10 patients attend, sometimes plus family members and hospital staff. In addition to the regular Sunday services, the Chaplaincy Volunteers organise the Carol Service in the afternoon of the nearest Sunday to Christmas. The chaplaincy volunteers have regular access to Michael Scoular, Hospital Chaplain, and he supports them to make it possible for the patients to get benefit from the Sunday worship together.

- On 24 May 2019 I shadowed the Site and Capacity Team in the Borders General Hospital for the morning to glean a greater understanding of the pressures the hospital can face and how good patient flow can enable some of those pressures to dissipate.

  was held on 30-31 May at the Scottish Event Campus (SEC), Glasgow. The theme
  of the event was 'Working Together, Improving Outcomes' and it provided an
  opportunity for those working in and with the NHS in Scotland to come together to
  consider the challenges, to share best practice and the most innovative approaches
  to delivering the highest quality of care, and to take away tools and techniques that
  would support them in their various roles.
