Request

I would be grateful if you could provide a schedule showing the following information for each month between January 2018 and March 2019 inclusive:

- 1) how many NHS patients were treated in private health care premises in each month, whether by an NHS or private doctor
- 2) the cost to your health board's budget of using private health care premises to treat patients in each month
- 3) if available, the number of patients for which you have used private health care providers in England for treatment in each month and the cost

I hope this request is clear that I am not interested in those patients who have elected to pay for private health care out of their own pockets, but rather those for whom you provided NHS-funded treatment in the premises of an independent healthcare provider.

Response

The information provided in this response has been extracted from the finance system. The finance system does not record patient details as part of a payment to an external provider. The following activity data has been provided by the waiting times team within NHS Borders and the financial information related to the total payments made to the provider at March 2019.

You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
