I am writing to you under the Freedom of Information (Scotland) Act 2002 and the Freedom of Information Act 2000 to request the following information on epilepsy:

- 1. Please can you provide the total number of specialist epilepsy nurses currently employed within your health board.
- 2. Please can you provide the total number of specialist epilepsy nurse posts, broken down by length of time vacant.
- 3. Please can you provide the a) longest and b) average waiting time, in each year since 2016, from being referred to receiving treatment.

Response

- 1. NHS Borders have 1 Specialist Nurse in Paediatrics but none in Adult services.
- 2. There is one Paediatric epilepsy nurse 30 hours (0.8WTE) in post with no vacancies.
- 3. NHS Borders cannot separate Adult Epilepsy waits from Neurology waits as they are on the same pathway, therefore under Section 15 Duty to provide advice and assistance of the FOI(S)A 2002 please find below the longest and average waiting time for a neurology appointment since 2016:

You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
