Response

NHS Borders has the facility within its adverse events reporting system to record on one report the number of times an event has happened over a 24 hour period. This is to facilitate low impact event reporting that happens on a frequent basis. The totals reflect this frequency reporting.

Previously we have been unable to extract this information from the system specifically for staff members. Due to an adjustment within the system this data collection is now possible.

You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
