- 3. What is the youngest age of an adolescent being held in an Intensive Psychiatric Care Unit within your region broken down for each of these years: 2018, 2017, 2016, 2015 and 2014?
- 4. What is the longest time period an adolescent has been held in an Intensive Psychiatric Care Unit within your region broken down for each of these years: 2018, 2017, 2016, 2015 and 2014?
- 5. How many Child and Adolescent Mental Health (CAMH) unit in-patient beds are available within your region?
- 6. How many patients have been held in "seclusion" (confined to their rooms) within Child and Adolescent Mental Health (CAMH) units in your region broken down for each of these years: 2018, 2017, 2016, 2015 and 2014?
- 7. What is the longest time period a patient has been held in "seclusion" (confined to their rooms) within Child and Adolescent Mental Health (CAMH) units in your region broken down for each of these years: 2018, 2017, 2016, 2015 and 2014?
- 8. What is the average duration of seclusion in Child and Adolescent Mental Health (CAMH) units in your region broken down for each of these years: 2018, 2017, 2016, 2015 and 2014?

- 15. What guidance has been issued regarding the safeguarding of adolescents placed alongside adults in Intensive Psychiatric Care Units within your region? I request that you supply documents in relation to this.

- 16. What policies are in place or guidance that has been distributed within your region regarding visits to:
  - a. Intensive Psychiatric Care Units and;
  - b. Child and Adolescent Mental Health units?

If following this review, you remain dissatisfied with the outcome, you may appeal to the Scottish Information Commissioner and request an investigation of your complaint. Your request to the Scottish Information Commissioner should be in writing (or other permanent form), stating your name and an address for correspondence. You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
