## BOARD COMMITTEE MEMBERSHIPS

### Purpose of Report:

The purpose of this report is to advise the Board of changes to the membership of Board Committees.

### Recommendations:

The Board is asked to <u>approve</u> the membership and attendance of Non Executive members on its Board and other Committees as recommended by the Chair.

### **Approval Pathways:**

This report has been produced for the Board.

### **Executive Summary:**

With the appointment of Karen Hamilton as Chair of Borders NHS Board in April 2019, a Non Executive vacancy was created and has been carried by the Board since then.

Dr Stephen Mather has intimated his intention to conclude his appointment as a Non Executive potentially by mid to end of May.

The Board is therefore recruiting for 2 appointments for Non Executives. Interviews are scheduled to take place on 19 and 20 March 2020.

In order to facilitate a handover of responsibilities from Dr Mather the following changes are proposed to take effect at his conclusion of appointment:-

- Clinical Governance Committee Stephen Mather withdraws as Chair of the Committee. Fiona Sandford nominated as Chair of the Committee.
- Health & Social Care Integration Joint Board (IJB) The role of Chair rotates to Scottish Borders Council (Cllr David Parker) from April 2020. Dr Mather steps down as Chair. Mr Malcolm Dickson takes on the role of Vice Chair of the IJB from April 2020.
- IJB Strategic Planning Group As a consequence of being the Vice Chair of the IJB, Malcolm Dickson becomes Chair of the IJB Strategic Planning Group from April 2020.

- Community Planning Partnership Strategic Board Mr Malcolm Dickson concludes deputising for the Chair. The Chair resumes her role as a member of the Board.
- With the appointment of Sonya Lam as a Non Executive of the Board from 1 February 2020, with Whistleblowing identified within her remit, Alison Wilson withdraws from the Whistleblowing Champion role.

It should also be noted that the Vice Chair is automatically a member of the following Committees:-

- Finance and Resources Committee
- Remuneration Committee
- Community Planning Partnership Strategic Board

As well as the proposed changes above a number of Committees will carry Non Executive membership vacancies until appointments to the Non Executive vacancies have been made:-
