All multiple pregnancies are cared for by a team led by a Consultant Obstetrician with a specialist interest in fetal medicine and multiple pregnancies. Ultrasound examination is carried out by the Consultant or a Midwife Sonographer. As a District General Hospital we do not have a specialist midwife. Care is supported by the Tertiary centre in NHS Lothian as required.

8. Finally, how many perinatal mortality reviews involving multiple births have been conducted since 2018 and what changes have been made as a result of them?

## There were <5 mortality reviews undertaken. There were no indications for changes in practice identified.

You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
