Within NHS Borders 565 cataract procedures were performed by Medinet in the period 1 April 2019 to 31 March 2020. Unfortunately we do not record electronically whether these patients were implanted with toric or non toric intraocular lenses. To extract this data would require a manual trawl of all patient records and the cost of carrying this out would exceed the limit set in the Fees Regulations of the FOI(S)A 2002 and therefore we are not required to provide.

c. YAG capsulotomy:

Within NHS Borders 196 capsulotomy procedures were performed by Medinet in the period 1 April 2019 to 31 March 2020.

There were <5 cataract procedures performed by the Golden Jubilee in the period 1 April 2019 to 31 March 2020. As the number of patients are very small and in accordance with the Code of Practice for Official Statistics any number that is less than five, actual numbers and potentially identifiable information is withheld to help maintain patient confidentiality due to potential risk of disclosure. You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
