## Freedom of Information request 423-20

## Request

- 1. As at 30 September 2020, what is the number of medical consultant posts (including NHS and honorary) in your board by WTE for the following (please note that all posts should be counted under ONE category only):
  - i. posts occupied by a permanent consultant
  - ii. newly-created posts which have not yet been advertised
  - iii. vacant posts according to the ISD definition ("a post which has been cleared for advert after being through the redeployment process (internal or external advert) and remains a vacancy until an individual starts in the post")
  - iv. vacant posts which are awaiting approval for recruitment
  - v. posts which although currently unfilled are not under active recruitment, e.g. where a previous recruitment exercise has been unsuccessful
  - vi. all posts occupied by a locum consultant (including consultants re-engaged as locums who previously held a permanent post and those locum consultants employed via an agency)
  - vii. posts that have been recruited to but applicant not yet in post (e.g. deferred start due to pending CCT)
  - viii. other (please be specific)

## Response

- 1. i. NHS Borders has 89 posts occupied by a permanent consultant.

  - iii. NHS Borders has 8 headcount vacancies; 7.30 Whole Time Equivalent (WTE) (Dermatology, Acute Medicine, Clinical Radiology, Haematology, Stroke /GIM, Paediatrics, Old Age Psychiatry)
  - iv. None.
  - v. NHS Borders has 5 headcount posts currently unfilled; 4.6 WTE (Dermatology, Acute Medicine, Clinical Radiology, Stroke /GIM, Obs & Gyn)
  - vi. NHS Borders has 10 headcount posts occupied by a locum consultant; 8.20 WTE (Old Age Psychiatry, GA Psychiatry, Ophthalmology, General Surgery, Respiratory Medicine, General Medicine, Obs & Gyn)
  - vii. Two posts have been recruited to but applicant is not yet in post (Consultant Paediatrics and Consultant General Surgery).
- As of 30 September 2020 there were 7 posts 6.3 WTE not held by a permanent substantive postholder since 31 March 2020.

You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
