- 3. What was the total number of individual overtime payments made to staff at director level and above, how many staff did this involve and what was the total cost of this? Please also provide any papers presented to the remuneration committee before these payments were approved.

You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
