Request

- 1. Please advise how many people have died of and with Covid to date in the health board area.
- 2. Of those who have sadly died "solely" of covid in the health board area, please advise the following:
 - a. Please advise the ages of the people and their gender
 - b. Please advise how many of them actually lived within the health board area as it is noted that some have been transferred into other health board areas and may have died there
 - c. Please advise what number of them were overweight
 - d. Please advise what number of them were underweight
 - e. Please advise what number of them took vitamin supplements daily
 - f. Please advise how each of them were infected by covid, i.e. being at work (what sort of job do they do?), visiting a care home, visiting a hospitality venue, visiting a neighbour, etc
 - g. What number of them were on any medication for any other medical issue
 - h. What number of them lived alone or lived with someone/others, ie family, nursing home, etc
 - i. What number of them had returned to the UK from overseas in 2020
- 3. Please advise how many people have died of the flu between the date covid deaths started to become recorded and now.
- 4. Please advise the current recorded population number for the health board area.

You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
