## Freedom of Information request 11-21

## Request

I would like to request the following information:

- 1. How many people have been admitted to hospital for treatment for an eating disorder (e.g. anorexia, bulimia) since March 2020? (Breakdown of month by month figures)
- 2. How many patients being treated for eating disorders have been moved to alternative wards/hospitals because of a lack of space/beds? (Month by month breakdown)
- 3. What is the average age of patients by admitted to hospital for eating disorder treatment since March 2020?
- 4. How many patients are currently being treated for eating disorders throughout your health board? (Breakdown of patients per hospital in health board)
- 5. Of the hospital admissions for eating disorders over the last 5 years what conditions (e.g. anorexia) were treated (breakdown of numbers per condition)?
- 6. How much capacity remains for the treatment of eating disorder patients throughout your health board (once taking current patients in to account)?

## Response

1. The table below details the number of patients living in the NHS Borders area admitted to hospital for an eating disorder, broken down by month between March 2020 and December 2020:

- 2. No patients being treated for eating disorders have been moved to alternative wards/hospitals as a result of a lack of space/beds in the period requested.
- 3. The average age of the patients admitted over this time period is 24.
- 4. There are no current in-patients in NHS Borders for eating disorders.

- 5. Patients living in the NHS Borders area admitted to hospital have been treated for the following conditions between 2016 and 2020:
  - Anorexia Nervosa (70 admissions)
  - Atypical Anorexia Nervosa (5 admissions)
  - Atypical Bulimia Nervosa (<5 admissions)
  - Unspecified Eating Disorder (28 admissions)
- 6. NHS Borders does not have specialist beds for eating disorder patients.

Please state the reference number **11-21** on this request. Your request should be made within 40 working days from receipt of this letter.

If following this review, you remain dissatisfied with the outcome, you may appeal to the Scottish Information Commissioner and request an investigation of your complaint. Your request to the Scottish Information Commissioner should be in writing (or other permanent form), stating your name and an address for correspondence. You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
