8.1	AW updated ADTC on progress of ward automated cabinets – as soon as ITU and Theatre available to Estates they will do the work to ensure ready for installation of cabinets and will review work required for ward 9, MKU and BSU followed by completion of work required. At this time all cabinets can be rolled out – expected to be April; can be delayed if required. Robotics - pharmacy robotic application has been reviewed by Capital Group and in February the Group will re-review and prioritise depending on other areas required. HEPMA: Health Improvement Scotland have started shared learning sessions; Dr C Kelly attended the first session with second one coming soon after which Dr Kelly and Head of IM&T JS will discuss how this will progress. Next step will be an outline business case to the Board for consideration and sign off. NHS Lothian has rolled out HEPMA to Edinburgh Royal and is in the process of rolling out to Western General; NHS Fife has put out to tender and have a preferred supplier. AW also updated ADTC that Dr Chris Evans is leaving NHS Borders in February and giving up his post as medical prescribing advisor. This post can be split into two (1PA per week flexible) with either one or two consultants able to apply – to be offered to all. Roles will require medical prescribing advisor/attending MRG and other medicines governance committee meetings and support for HEPMA – this is to be discussed with Dr C Kelly, new Clinical CIO/eHealth Lead.
