Freedom of Information request 193-21

Request

1. Can you please provide the total number of deaths that occurred within the NHS Borders Board, where a positive PSR Covid-19 test was taken within 28 days of the persons death.

Can you please provide this information by date (including a total for 2020 and 2021) from February 2020 to todays date (24/5/2021).

Can you please provide this information in 5 year age group bands

2. Can you please provide the total number of deaths that occurred within the NHS Borders Board, where a positive PSR Covid-19 test was taken within 28 days of the persons death AND Covid-19 was the sole cause of death listed on the deceased's death certificate

Can you please provide this information by date (including a total for 2020 and 2021) from February 2020 to todays date (24/5/2021).

Can you please provide this information in 5 year age group bands

CLARIFICATION:

I am asking for all patients that have been treated by NHS Borders Health Board – I appreciate that you may not readily have access to wider information to patients that have died in care home settings or at home. However, if you do have this information, I would appreciate both sets of data.

Note also that in my original FOI on 24/5/2021 I made a typo by referencing PCR test as PSR. I have corrected that below.

Response

1. There have been a total of 71 inpatient deaths within NHS Borders hospitals where the patient died within 28 days of having had a positive Covid-19 PCR Test. Please note that as NHS Borders is such a small Board and the number of deaths by date is small, to provide further details could allow individuals to be identified and we would be in breach of the Data Protection Act 2018. We are therefore presenting the data by month:

There have been a total of 7 inpatient deaths within NHS Borders hospitals where the patient died within 28 days of having had a positive Covid-19 PCR Test, where the sole cause of death recorded on National Register Scotland is recorded as 'U07.1 COVID-19, virus identified is assigned to a disease diagnosis of COVID-19 confirmed by laboratory testing'. Please note that as NHS Borders is such a small Board and the number of deaths by date is very small, to provide further details could allow individuals to be identified and we would be in breach of the Data Protection Act 2018. Please state the reference number **193-21** on this request. Your request should be made within 40 working days from receipt of this letter.

If following this review, you remain dissatisfied with the outcome, you may appeal to the Scottish Information Commissioner and request an investigation of your complaint. Your request to the Scottish Information Commissioner should be in writing (or other permanent form), stating your name and an address for correspondence. You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
