Request

- 1. Dates of all communication from the Scottish Government regarding continuity plans for cancer services since September 2019 to the date of this FOI
- 2. Emergency plans that were specific to the treatment of cancer for all possible emergencies including during COVID
 - Cancer treatments that were deemed priority
 - Priority matrix that was used to determine prioritisation
 - What determined a service to be suitable to be paused
 - Demand for treatment versus capacity for treatment since 1st March 2020
- 3. Emergency plans in place for all emergencies by type of emergency and how often they are updated
- 4. Changes to cancer diagnosis and treatment pathways before, during and after COVID with dates of changes
- 5. The number of patients screened through screening service provision in August 2018 to July 2019 (inclusive) and August 2020 to July 2021 (inclusive)

- 2. Please see below for the emergency plans that were specific to the treatment of cancer for all possible emergencies including during Covid-19 at NHS Borders:
 - Cancer treatments that were deemed priority and all patients with a confirmed cancer diagnosis have been deemed as the highest priority.
 - NHS Borders worked to the National Prioritisation Framework issued by the Scottish Government to NHS Boards in November 2020, this can be found at <u>https://www.gov.scot/publications/supporting-</u> <u>elective-care-clinical-prioritisation-framework/pages/clinical-classification-of-patients</u> and therefore under Section 25 of the Freedom of Information (Scotland) Act 2002 is accessible elsewhere.
 - Clinical teams were asked to prioritise patients waiting according to the national framework mentioned above, and clinical judgement in respect of relative urgency. As a Board, capacity was protected for the highest priority patient groups, that being in order of priority emergency care, cancer

care and then other urgent care. On that basis elements of care were protected in a majority of clinical services, the actual was level dependant on the proportion of work associated with higher priority or cancer activities. NHS Borders established both a Clinical Prioritisation Group, and a Clinical Prioritisation Board to ensure decision were consistent and clinically led.

- 4. The changes to cancer diagnosis and treatment pathways before, during and after Covid-19 at NHS Borders:
 - In March 2020, some patients requiring surgery for Breast cancer were started on hormone treatment to delay progression of cancer so that surgery could be delayed.
 - For January to March 2022, patients suitable for surgery at Golden Jubilee are being referred there for Colorectal surgery as there are risks around local ITU capacity
