## Freedom of Information request 96-22

## Request

- 1. How many patients have been treated with the following drugs in the past 4 months:
- a. Erenumab (Aimovig) any disease
- b. Fremanezumab (Ajovy) any disease
- c. Galcanezumab (Emgality) any disease
- d. Botulinum Toxin (i.e., Botox, Dysport, Xeomin) migraine ONLY
- 2. I would like to understand the source of funding of Botox and anti-CGRP monoclonal antibody treatments (Ajovy, Aimovig, Emgality) for migraine. Could you please answer the following questions:
- a. Does the trust commission/fund Botulinum Toxin treatment for migraine (Y/N)?
- b. Does the trust commission/fund anti-CGRP treatments for migraine (Y/N)?
- c. In case the trust actively provides Botulinum Toxin treatment for migraine but does not commission/fund it, then please provide the name(s) of the other NHS organisations that commission/fund these treatments at your trust.
- d. In case the trust actively provides anti-CGRP treatments for migraine but does not commission/fund them, then please provide the name(s) of the other NHS organisations that commission/fund these treatments at your trust.

## Response

- 1. In the past 4 months:
  - a. There have been 15 patients treated with Erenumab (Aimovig) for any disease
  - b. There have been <5 patients treated with Fremanezumab (Ajovy) for any disease
  - c. There have been no patients treated with Galcanezumab (Emgality) for any disease
  - d. There have been no patients treated with Botulinum Toxin (i.e., Botox, Dysport, Xeomin) for migraine only.

- a. No, NHS Borders does not commission/fund Botulinum Toxin treatment for migraine.
- b. Yes, NHS Borders does commission/fund anti-CGRP treatments for migraine.
- c. Not applicable.
- d. Not applicable.

As NHS Borders is such a small Board and the number of some patients is very small, to provide further details could allow individuals to be identified and we would be in breach of the Data Protection Act 2018. We are therefore withholding all other data under Section 38(1) of the Freedom of Information (Scotland) Act 2002. This is in accordance with the Code of Practice for Official Statistics that any number that is less than five, actual numbers and potentially identifiable information is withheld to help maintain patient confidentiality due to potential risk of disclosure. The request for a review should include your name and address for correspondence, the request for information to which the request relates and the issue which you wish to be reviewed. Please state the reference number **96-22** on this request. Your request should be made within 40 working days from receipt of this letter.

If following this review, you remain dissatisfied with the outcome, you may appeal to the Scottish Information Commissioner and request an investigation of your complaint. Your request to the Scottish Information Commissioner should be in writing (or other permanent form), stating your name and an address for correspondence. You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
