Response

- 1. NHS Borders has 37 sites and 72 buildings
- 2. We have a mixture of lighting technologies across all sites/buildings including all the types mentioned.
- 3. Yes we have PV panels at the Borders General Hospital, Melrose.
- 4. The BMS system in place is Siemens Desigo System, this covers all sites within NHS Borders.
- 5. No, there is no hard services external Facilities Management company under Contract with NHS Borders.
- 6. Bed figures within NHS Borders have been consistent for the last 3 years, please see figures below:
 - Borders General Campus 328 beds
 - Hawick Community Hospital 23 beds
 - Haylodge Community hospital 23 beds
 - Kelso Community Hospital 23 beds
 - The Knoll Community Hospital 23 beds
 - East Brig, Galashiels 12 beds
- 7. NHS Borders does not have a Green Plan as this is an NHS England initiative, therefore this information is not held, as defined in Section 17, Freedom of Information (Scotland) Act 2002. Please note however that during 2022 the Board will be developing a Net Zero Route-Map in line with the recently published NHS Scotland Climate Emergency & Sustainable Development policy and strategy.

If following this review, you remain dissatisfied with the outcome, you may appeal to the Scottish Information Commissioner and request an investigation of your complaint. Your request to the Scottish Information Commissioner should be in writing (or other permanent form), stating your name and an address for correspondence. You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
