- 3. In this health board, of those patients who were discharged from hospitals into care homes, how many did not complete a Covid test before their discharge? Please provide the data for the calendar year 2020 and 2021.

- 3. In this health board, of those patients who were discharged from hospitals into care homes, how many did not complete a Covid test before their discharge? Please provide the data for the calendar year 2020 and 2021.

Response

- 1. There were 518 patients discharged from NHS Borders hospitals to care homes in 2020 and 449 patients discharged to care homes in 2021.
- 2. The following table summarises the number of patients discharged from NHS Borders hospitals to Care Homes receiving tests within 2 days before and within 5 days before discharge:

NHS Borders Care Home Discharges	2020	2021
Received Covid test before discharge	358	446
Received Covid test within 5 days of discharge	329	419
Received Covid test within 2 days of discharge	257	361

3. The following table summarises the number of patients discharged from NHS Borders hospitals to Care Homes not receiving tests within 2 days before and within 5 days before discharge:

NHS Borders Care Home Discharges	2020	2021
Did not receive a Covid test	160	<5
Did not receive Covid test within 5 days of discharge but did receive a test	29	27
Did not receive Covid test within 2 days of discharge but did receive a test	101	85

If following this review, you remain dissatisfied with the outcome, you may appeal to the Scottish Information Commissioner and request an investigation of your complaint. Your request to the Scottish Information Commissioner should be in writing (or other permanent form), stating your name and an address for correspondence. You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
