Request

I am looking for information regarding the use of locum nurses by your health board for the financial years 2017/18 to 2021/22.

By 'locum nurses' I mean any medical nurse employed through an agency or through an NHS bank, rather than by the health board. I would be grateful if these questions could be treated as separate FOIs.

In particular, can I request the following for the financial years 2017/18 to 2021/22:

- 1) The total locum agency spend, with a breakdown for locum nurses working in both acute settings and in primary care;
- 2) The total locum agency spend for nurses working in Accident and Emergency/ Emergency Departments;
- 3) The total number of shifts worked by locum nurses, with a breakdown by acute and primary care.
- 4) Please provide the 10 highest amounts of money paid by the Health Board to a locum nurses for working a single shift.
- 5) Names of each agency used by the Health Board to provide locum nurses.
- 6) Total amount of money paid by the Health Board to each of those agencies.

Response

The information we hold is not in the format requested as the Finance System does not detail the charge for each individual shift but is a consolidated invoice from the relevant Agency Nursing supplier. To look for a similar hourly rate within all of the invoices received for agency nurse shifts worked during this time period would require a manual trawl and the cost of carrying out this work would exceed the limit set in the Fees Regulations of the FOI(S)A 2002 therefore under Section 12 cost of compliance we are not required to provide.
- 5&6 Please find below details of the total spend in each of the financial years for Agency costs by agency provider, however it should be noted that in November 2020 the Management of Bank and Agency staffing transferred to NHS Lothian therefore NHS Borders didn't; necessarily pay off the amounts detailed below to the specified agencies within those years.

Please state the reference number **248-22** on this request. Your request should be made within 40 working days from receipt of this letter.

If following this review, you remain dissatisfied with the outcome, you may appeal to the Scottish Information Commissioner and request an investigation of your complaint. Your request to the Scottish Information Commissioner should be in writing (or other permanent form), stating your name and an address for correspondence. You should provide the details of the request and your reasons for dissatisfaction with both the original response by NHS Borders and your reasons for dissatisfaction with the outcome of the internal review. Your application for an investigation by the Scottish Information Commissioner must be made within six months of your receipt of the response with which you are dissatisfied.
