## Request

- 2. In this health board, what is the total number of clinical staff waiting to access Occupational Health Services? Please provide this data as a number and as a percentage of the total number of clinical staff in the health board. Where clinical staff have requested an appointment with Occupational Health Services, please provide the reasons for their absence e.g. Covid, burnout, stress, mental health, illness.
- 3. In this health board, during 2022/23 so far, what is the average waiting time for members of clinical staff to access Occupational Health? Please provide the average waiting time and the longest waiting time. Please also provide the data for the financial years 2021/22, 2020/21, 2019/20, 2018/19 and 2017/18.

## Response

1. As at the current time 92 clinical staff were on sick leave which equates to 3.62% of total number of clinical staff in the Board. The reasons are shown below:

- 2. There are 40 clinical staff currently awaiting access to Occupational Health and all have an appointment booked for June/July 2022; this equates to 1.5% of total number of clinical staff in the Board. The reason for absence is clarified at appointment therefore we do not hold this data at this point in time.
- 3. The average and maximum waits for Occupational Health are:
